## A) Documents required to be uploaded along with technical bid.

- 1) The contractor should upload the photo copy PWD Registration of current Block period with his photo on the document which is clearly visible
- 2) The contractor should upload original Line of Credit Certificate to the extent of 30% of amount put to tender issued by any nationalized bank
- 3) The contractor should upload photo copy of PAN card, latest VAT clearance certificate.
- 4) The contractor should upload photo copy of Income tax returns for the last financial year(Assessment Year 2016-17).
- 5) The contractor should upload original work done certificate during the last three Financial years (2013-14, 2014-15, 2015-2016) to the extent of 50% Amount put to tender issued by an officer not below the rank of Executive Engineer for having completed single building work in any financial year.
- 6) The contractor should upload D.D towards Performance Security to the extent 6.5% of amount put to tender drawn in favor of Finance Officer, Gulbarga University. This would be refunded after completion of one year maintenance period.

## B) Documents to be uploaded along with financial bid.

- 1) Duly filled schedule-B.
- 2) The contractor who quotes less than the amount put to tender should upload the DD for the difference amount of Nationalized Banks/Scheduled Banks drawn in favor of Finance Officer, Gulbarga University

## Terms & Conditions

- 1) The original difference DD should be produced at the time of acceptance of lowest tender. The D.D. for the difference amount will be refunded after successful completion of work. If failure to produce DD the tender will be rejected.
- 2) The rates quoted in the tender should be valid for 6 months from the date of opening of the tenders. Conditional tenders will be rejected.
- 3) The right to make any additions & deletions in the above works is reserved by the University.
- 4) The contractor should analyze the specification of all items and work spot before quoting their rates.
- 5) If the work is not completed within the stipulated time allowed, penalty will be levied. For further delay, the work will be terminated and balance work will be got done through other agency at cost & risk.
- 6) The royalty charges towards building materials will be deducted as per latest Notification issued by mines and Geology Department, Government of Karnataka and the agencies should abide accordingly.
- 7) The right to reject any or all tender without assigning any reason is reserved with the competent authority. It may be noted that, the works are under Third Party Inspection
