

**QUALIFICATIONS FOR ASSIGNMENT AS GUEST LECTURERS**  
**(As per UGC/AICTE Norms)**

**Qualification:** Good academic record with at least 55% of the marks or an equivalent grade of B in the 7 point scale with letter grades O, A, B, C, D, E & F at the Master's Degree level, in the relevant subject from an Indian University or an equivalent degree from a foreign University. Besides fulfilling the above qualifications, candidates should have cleared the eligibility test (NET/SLET) for Lecturers conducted by the UGC, CSIR or similar test accredited by the UGC.

- i) A relaxation of 5% may be provided from 55% to 50% of the marks at the Master's level for the SC/ST category.
- ii) A relaxation of 5% may be provided from 55% to 50% of the marks to the Ph.D. Degree holders who have passed their Master's degree prior to 19<sup>th</sup> September, 1991.
- iii) B in the 7 point scale with letter grade O, B, C, D, E & F shall be regarded as equivalent of 55% wherever the grading system is followed.
- iv) A relaxation of the minimum marks at the P.G. level from 55% to 50% for appointment as Lecturer may be provided to the candidates who have cleared the JRF examination conducted by UGC/CSIR only, prior to 1989, when the minimum marks required to appear for JRF examination were 50%.
- v) NET/SLET/SET shall remain the minimum eligibility condition for appointment of Guest Lecturers in University. Provided, however, the candidates, who are or have been awarded Ph.D. degree in compliance of the "University Grants Commission (minimum standards and procedure for award of Ph.D. Degree), Regulations 2009 and 2016, shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET.

"Provided further, the award of degree to candidates registered for the M.Phil/Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bylaws/Regulations of the Institutions awarding the degree and the Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/ Colleges/Institutions subject to the fulfillment of the following conditions:-

- a) Ph.D. degree of the candidate awarded in regular mode only;
- b) Evaluation of the Ph.D. thesis by at least two external examiners;
- c) Open Ph.D. viva voce of the candidate had been conducted;
- d) Candidate has published two research papers from his/her Ph.D. work out of which at least one must be in a referred journal;
- e) Candidate has made at least two presentations in conferences/ seminars, based on his/her Ph.D. work.  
(a) to (e) as above are to be certified by the Vice-Chancellor/Pro-Vice-Chancellor/Dean (Academic Affairs)/Dean (University Institutions)."
